Weld County-Wide Initiatives and Goals



By 2024, the Reading Great by 8 community-wide goal is to increase the percentage of Weld County children reading to learn by the beginning of 4th Grade from 39% to 43%.



By 2024, the Thrive by 25 community-wide goal is to increase the percentage of Weld County youth who have a connection to a caring adult to a solid 75%.



By 2024, the Weld's Way Home community-wide goal is to decrease the number of people that are living out-of-doors or in a car in Greeley/Evans from approximately 236 to fewer than 100.



City of Evans, City of Greeley and Garden City are now members of the AARP Network of Age-Friendly Communities; the goal is to lead the community in becoming more age friendly.

What Your Dollars Can Do

From a child turning the pages of her first book, to a youth having a caring adult taking an interest in them, to a family finding the resources they need to stay in their home, to an older adult having the support to live an independent life – when you invest in United Way, you touch the lives of real people.

\$5 a week provides 3 visits with new parents to offer tools that ensure their child is ready to enter Kindergarten.

\$2 a week means 2 youth can attend after-school programs that lead to life success.

\$10 a week provides a night out of the cold for 34 people experiencing homelessness during the cold weather season.

\$3 a week provides 11 rides for older adults to run errands and attend medical appointments.

\$7 a week links twelve 211 callers to get the help that they need.

Invest in Household Stability Work or Improving Child Care and Get a 25% or 50% State of Colorado Tax Credit

For a donation of \$100 or more, you can get a State of Colorado tax credit for your contribution. Donations to United Way's Housing Navigation Center qualify for a 25% tax credit. Donations to United Way's child care quality improvement activities get a 50% tax credit. This is in addition to regular state and federal tax deductions.

To get the credit, note your wishes on your pledge form, check, or in the designation section of your online contribution. The state requires the last four digits of your social security number or a FEIN when a donation is made.
