**WELD PROJECT CONNECT  
LIABILITY WAIVER/PHOTO RELEASE and OATH OF CONFIDENTIALITY**

the following terms and provisions in consideration of my participation in any and all volunteer activities of Weld Project Connect, an accessible, user-friendly one-day event for individuals and households struggling and in need due to foreclosure, job loss, age, health problems and other issues that can interrupt a life, ("Event"); to be held on Thursday October 17, 2024, sponsored by United Way of Weld County, a non-profit and charitable organization, the City of Greeley and Weld County, a partnership formed by the entities (collectively, "Sponsors").

PARTICIPANT acknowledges and agrees that volunteer activities undertaken with the Event:

- Include diverse activities that could result in harm or injury to PARTICIPANT, whether physical or mental, or damage to property from the participation in such activities.
- May involve promotional activities including television, radio, or newspapers that would cause sound records, photographs, and/or video to be taken and published of PARTICIPANT for the purpose of promoting the Event and the Sponsors and their activities.
- Require PARTICIPANT'S unconditional permission for the use of such photographic, video images, or sound recordings for promotional activities of the Event and the Sponsors and their activities.
- Do not entitle PARTICIPANT to reimbursement or compensation for such volunteer activities or any other benefit to which an employee or independent consultant might be entitled to in consideration for the performance of certain activities.

I, on behalf of myself and anyone who obtains any rights from me, hereby forever release, discharge, and covenant not to sue the Sponsors, and their respective parents, subsidiaries, affiliates, directors, officers, employees, agents, partners, administrators, volunteers, insurers, successors and assigns of each of the foregoing (collectively, "Releasee"), from any and all liability, claims, demands, losses, damages, costs or expenses (including, without limitation, attorneys' fees and costs) (collectively, "Losses") arising out of or in any way related to my participation in the Event and related activities, including, but not limited to, Losses caused or alleged to be CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE of any Releasee or otherwise, including negligent rescue operations. I further agree to release and hold harmless each Releasee from and against any Loss regarding any matter within the scope of this Volunteer Agreement.

No statements regarding the effect of this Volunteer Agreement, not contained in this Volunteer Agreement, shall modify the terms of the Volunteer Agreement. In any proceeding or other attempt to enforce, construe or to determine the validity of this Volunteer Agreement, the non-prevailing party will pay the reasonable expenses of the prevailing party, including, without limitation, reasonable attorneys' fees and costs. This Volunteer Agreement shall be binding upon the undersigned and his/her successors, assignees, subrogors, heirs, next of kin, and legal and personal representatives. This Volunteer Agreement shall be governed by and construed in accordance with the laws of the State of Colorado. Exclusive jurisdiction and venue for any dispute concerning this Volunteer Agreement shall be in the district or county courts located in Weld County, Colorado.

I also hereby confirm, represent and warrant that I have never been arrested or convicted for a violent crime, child abuse or neglect, child pornography, child abduction, kidnapping, rape or any sexual offense, nor have I been ordered by a court to receive mental health treatment in connection with any of the foregoing.

By signing this Volunteer Agreement, I acknowledge that I have read, understand, and voluntarily agree to its terms. I also represent and warrant that I am of legal age to sign this Volunteer Agreement. If PARTICIPANT is under the age of 17, I hereby consent as the parent or legal guardian of the PARTICIPANT to all the terms and provisions contained above and further acknowledge that I have read and understand the terms and provisions

**OATH OF CONFIDENTIALITY**

I understand that:

1. The purpose of gathering and sharing private information during my participation in the Event is to improve housing and health outcomes for the families served at WPC ("Event Participants").
2. Sharing of personal information of Event Participants will be limited to that which will achieve this purpose and will be limited to the day of the Event, October 17, 2024.
3. I will not release any protected health information including mental health and substance abuse information that has not been authorized for release by the Event Participant.
4. I will respect the privacy of the Event Participant(s) that I am volunteering with and serving during the Event. I will not share any private information about the Event Participant(s) after October 17, 2024.
